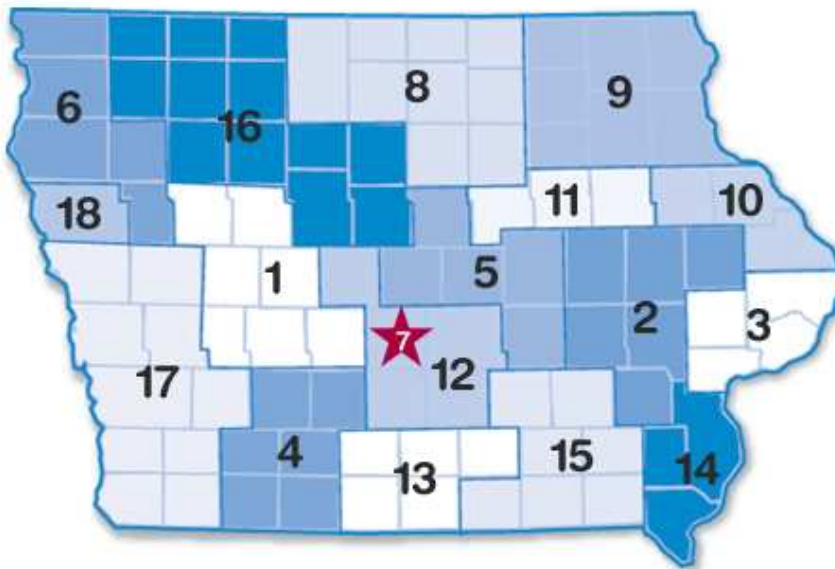




ICAA Member Agencies (Iowa Community Action Association)
